USE OF CLUB AND UPTON WARREN CENTRE- OWNED BOATS

- Some Club owned and Centre owned boats are available for members' use during Club sessions
- Sailing Club members are expected to treat Club and Centre property with care.
- Although Club and Centre boats are insured, an insurance claim excess operates.
- If a Club/Centre-owned boat is involved in an incident either on or off the water during a Sailing Club activity, resulting in damage to boats or property, then the club member(s) sailing the Club/Centre boat may be held to be responsible for any insurance excess. (currently up to a maximum of £100).

THE REGISTRATION AND USE OF PRIVATE BOATS

1. RULES FOR UWSC MEMBERS WHO WISH TO SAIL PRIVATE BOATS AT UPTON WARREN: -

- All owners must have boat insurance to include Third Party Accident cover to the minimum value of £1,000,000
- All craft must be in a seaworthy condition and when raced must comply to the spirit of the Class rules
- Private boats may be sailed at the Centre on occasions other than at Club times only by prior arrangement with the Centre Staff
- Members who have not been allocated a space in the Boat Park may only keep their craft at the Centre for the duration of the Club day/weekend.
- Access to the boats can only be obtained by arrangement with the Centre Staff who hold the necessary keys
- The County Council, the Upton Warren Outdoor Education Centre and the Sailing Club accept no responsibility for the loss or damage to equipment, or to craft left or used at Upton Warren Sailing Club
